Designed by noted Brazilian architect Jonas Birger, the Carrão project will benefit from continued interest in the area among São Paulo residents.

Commenting on today's announcement, Josh Pristaw, Managing Director of GoldenTree InSite Partners, noted: "As evidenced by these two initial deals, this alliance with Quality will give us access to a substantial deal pipeline in addition to significant proprietary deal flow for years to come. "This partnership underscores our commitment to Brazil, where we will continue to be very active," he added.
